We do obey all legal and social compliances guided by laws and regulatory bodies as per local Govt. order and Global requirements. Some of our major compliance issues are:

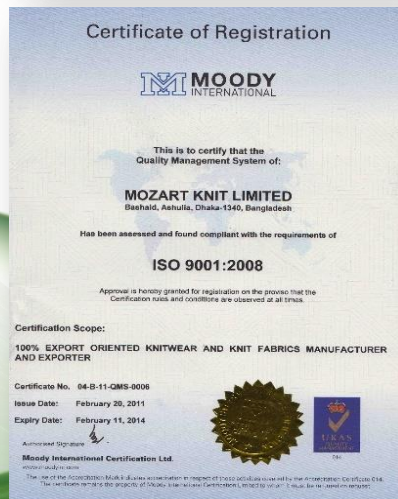
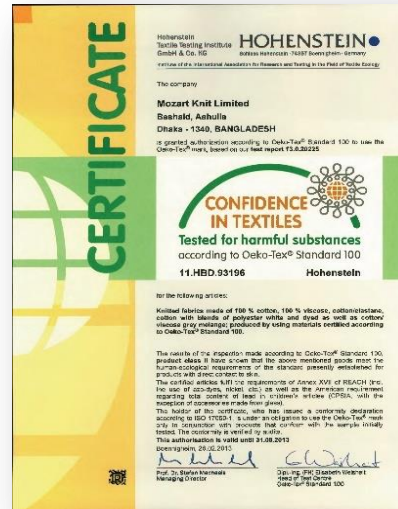
- ☐ We do not hire Employee under 18 years.
